## **Recent changes to the PASRR Program - Trends, Compliance**

The presentation will focus on recent changes to the Preadmission Screening and Resident Review (PASRR) program (i.e. Level I form, referral process, add-on to the nursing facility rate, etc.), recent trends in PASRR referrals, and providers' compliance with the PASRR process.

- Apply knowledge to avoid making common errors when completing PASRR Level I forms or making referrals for PASRR Level II evaluations

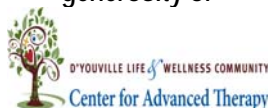
